3. Supervisory activities of the Board of Directors to the Board of Management

The Board of Directors has directed and closely followed the Board of Management in implementing the content of resolutions of the General Meeting of Shareholders and the Board of Directors to guarantee the deployment of business activities in accordance with the strategy and plan approved by the General Meeting of Shareholders and the Board of Directors. In addition, each member of the Board of Directors also directly supervises the activities of the Board of Management according to the assigned work to be able to lead in a timely manner, and regularly make assessment to offer appropriate and effective solutions.

In addition, the Board of Directors has also assigned an independent member of the Board of Directors, in addition to performing his duties as an independent member of the Board of Directors of the Bank in accordance with the provisions of the Law, the Charter and relevant regulations of LienVietPostBank, to also take responsibility for supervising and urging the Board of Management and related units of the Bank to implement the Resolutions and Decisions of the Board of Directors (quarterly reporting in writing to the Board of Directors).

4. Activities of Committees under the Board of Directors

a. Human Resources Committee

Make decisions on personnel issues within the assigned authority.

Make appraisal to submit to the Board of Directors for approval and decision on personnel decentralization issues that are beyond the authority of the Committee.

c. Anti-Money Laundering Committee

Advise the Board of Directors in planning strategies related to anti-money laundering, ensuring in accordance with the business strategy, provisions of the Law and the Charter of the Bank; make decisions to approve investments, transactions related to the prevention and combat of money laundering throughout the banking system; in the management and supervision work, implement the Bank's guidelines and policies on money laundering prevention and combat.

Research and give warnings about the Bank's safety against potential perils and risks and preventive measures for risks related to money laundering prevention and combat in the short and long terms.

Review and evaluate the suitability and effectiveness of current anti-infection regulations and policies to make recommendations and proposals to the Board of Directors.
