3. Supervisory activity of the Board of Directors over the Board of Management:

Board of Directors' supervision over Board of management is always ensured and focused. In accordance with current laws, the Bank's Charter, the Regulation on organization and operation of the Board of Directors and LPBank's internal regulations, the Board of Directors has held periodic meetings to supervise the activities of Board of management in operating business activities and implementing all resolutions, decisions of the General Meeting of Shareholders, Board of Directors and the directions of the Board of Directors.

Each member of the Board of Directors also directly supervises the activities of Board of management as well as the activities of each Division to be able to direct in a timely and effective manner.

4. Activities of Committees under Board of Directors

By December 31, 2024, the Committees of the Board of Directors include 03 Committees assisting the Board of Directors to ensure full compliance with relevant laws. The Committees operate very actively and effectively, promoting the role of advising and recommending the Board of Directors to perform their tasks and powers in accordance with the law, in order to promptly support LPBank's business activities as well as risk management.

a. Human Resources Committee

Human Resources Committee under Board of Directors has the highest role in advising the Board of Directors to manage and supervise the implementation of guidelines, policies, statutes and regulations of law and of LPBank on human resources matters: (i) Advise the Board of Directors on the size and structure of the Board of Directors, Management person in line with the scale of operations and development strategy of LPBank; (ii) Advise the Board of Directors to handle personnel issues arising in the process of carrying out procedures for election, appointment, dismissal and discharge of Board of Directors' members, Board of Supervisory's members and Executives of LPBank in accordance with the provisions of law and the Bank's Charter; (iii) Study and advise the Board of Directors in promulgating internal regulations of LPBank under authority of the Board of Directors on salary, remuneration, bonuses, regulations on personnel selection, training and other remuneration policies for Executives, officers and employees of LPBank; (iv) Focal point in organizing the research and direction of the implementation of strategic projects on the organizational structure and operation of LPBank to advise and propose to the Board of Directors in formulating strategies and policies on governance, human resource development and organizational structure; (v) Research and advise the Board of Directors to decide on policies and solutions for human resource management of LPBank in the direction of development and business in each period. Salary policies and remuneration regimes are in line with LPBank's business performance, development and business orientations from time to time. Headcount of the entire LPBank system in each period. Recruitment, appointment, dismissal, discharge, transfer, employee reassignment and other issues related to personnel matter under the authority of the Board of Directors; (vi) Study and appraise for submission to the Board of Directors for tasks related to personnel when assigned by the Board of Directors; (vii) To propose and recommend contents related to the functions and tasks of the Committee in order to improve the operational efficiency of LPBank.

b. Risk Management Committee

Risk Management Committee (RM) under the Board of Directors plays an important role in formulating risk management policies, risk management apparatus, risks monitoring of LPBank:

For the risk management area, the Risk Management Committee plays the following roles: (i) Advise the Board of Directors in promulgating processes and policies under authority related to risk management in banking activities in accordance with the law and the Bank's Charter; (ii) Analyze and issue warnings about the safety level of LPBank against risks, potential risks that may affect and preventive measures for these risks in the short and long term; (iii) Consider and evaluate the appropriateness and effectiveness of LPBank's current risk management processes and policies to make recommendations and proposals to the Board of Directors on the requirements to change current processes, policies, operational strategies, and risk management organizational structure; (iv) Advise the Board of Directors in planning investments to be made in the fiscal year, deciding approval for investments, related transactions, governance policies and risk management plans within the scope of functions and tasks assigned by the Board of Directors; (v) Supervise and report to the Board of Directors on the implementation of decisions and resolutions of the Board of Directors related to LPBank's risk management; (vi) Advise and propose to the Board of Directors to supervise Board of management's members in: Developing and organizing the implementation of risk management policies; handling and overcoming shortcomings and limitations in risk management according to the requirements and recommendations of the SBV, organizing independent audit and other functional agencies; other contents prescribed by the Board of Directors; (vii) Research and advise the Board of Directors to decide on issues under authority related to LPBank's risk management.

For anti-money laundering ara, the Risk management Committee plays the following roles: (i) Advise and assist the Board of Directors in planning strategies related to the antimoney laundering, ensuring conformity with business strategies, actual developments of the market, the provisions of law and the Bank's Charter; (ii) Advising the Board of Directors in promulgating policies and regulations under authority related to the antimoney laundering in banking activities in accordance with the provisions of law and the Bank's Charter; (iii) Advising and assisting the Board of Directors in supervising the implementation of guidelines, policies and regulations of law and LPBank on anti-money laundering. Consider and evaluate the appropriateness and effectiveness of LPBank's current guidelines, policies and regulations on anti-money laundering in order to make recommendations and proposals to the Board of Directors; (iv) Advising and assisting the Board of Directors in assessing risks at LPBank, measures to prevent, detect, warn, preclude and handle threats and risks of money laundering including in the short and long term; (v) Study and advise the Board of Directors to decide on issues under authority related to the anti-money laundering of LPBank.

c. Strategy Committee

In 2024, the Transformation Committee has been merged into the Strategy Committee. The Strategy Committee plays an important role in: (i) Advising the Board of Directors to plan LPBank's development strategy, including the content of LPBank's transformation; developing an implementation roadmap and expected budget to implement LPBank's development strategy according to the objectives of the Board of Directors (ii) Research, advise and propose to the Board of Directors on development strategies in line with the operational orientation of LPBank in each period; develop institutional documents on LPBank's development strategy (iii) Research and advise the Board of Directors on solutions to effectively implement the contents/requirements in LPBank's development strategy (iv) Research, appraise and submit to the Board of Directors (v) Advise the Board of Directors in inspecting, supervising and evaluating the implementation of guidelines, policies, statutes, regulations and progress on LPBank's development strategy; propose and recommend measures to adjust the strategy, remedy or promote it to ensure that the development strategy is on schedule and effectively.

In the year of 2024, LPBank dissolved the Investment Committee.

3. Supervisory activities of the Board of Supervisors towards the Board of Directors, the Board of management and shareholders:

The Board of Supervisors supervises the compliance with the provisions of the law and the Charter of LPBank in the management, administration and implementation of the resolutions of the General Meeting of Shareholders for the Board of Directors and the Board of management.

The Board of Supervisors supervises the management and administration of the Bank in compliance with the provisions of the law, internal regulations, charter and

resolutions/decisions of the General Meeting of Shareholders, the Board of Directors and CEO.

Supervise the current financial situation, appraise financial statements, supervise the compliance with regulations on restrictions/limitations to ensure the Bank's safety of the operation.

In addition, the Board of Supervisors also supervises senior management for internal audit in accordance with the law.

4. Coordination between the Board of Supervisors' activities and operation of the Board of Directors, the Board of management and other management staffs:

The Board of Supervisors regularly coordinates with the Board of Directors, the Board of management and other managers to properly perform their functions and tasks. The Board of Supervisors regularly participates in regular/periodic meetings of the Board of Directors, progress meetings of the Board of Directors. The Board of Supervisors is also provided with information and documents on the management, administration and business activities of the Bank serving for the Board of Supervisors' activities.

Through control activities, the Board of Supervisors has made opinions and recommendations to the Board of Directors and the Board of management on measures to strengthen control, reduce risks, ensure compliance with the provisions of the draft law, Charter and internal regulations of LPBank, contributing to improving quality, efficient and safe operation of the Bank.
